#### Public Open Forum:

- Defibrillators: There are two defibrillators in Derrington (Village Hall, Millennium Green) which are currently maintained by volunteers. MOP Roy Wood asked if SPC can assume responsibility for them and fund replacement batteries/pads. Cllr Brown offered to oversee maintenance of the Derrington defibrillators and SPC will fund the upkeep for all parish defibrillators Derrington, Seighford (Hollybush Pub) and Great Bridgeford (Village Hall). Proposed: Cllr Blackmore. Seconded: Cllr Burgess. Approved.
- Dog-waste bags: The dog disposal bags provided by SPC for community
  use are getting more expensive, so Mr Wood, who administers the bags,
  suggested discontinuing the supply once current stock is used. Cllr Hayward
  suggested monitoring it once they cease to see if there is an increase in dog
  mess. It was agreed to not order another batch. Proposed: Cllr Brown.
  Seconded: Cllr Hayward. Approved.
- Seighford Lakes query: Cllr Hayward read out email from MOP who had purchased land by Seighford Lakes but is having issues with a neighbour and

asked if SPC can raise with SBC. Present SBC Cllr Rose asked for the details and will follow-up accordingly.

## **Updates from Borough/ County Councillors:**

Cllr Jack Rose representing both SBC and SCC.

- Dale Lane: Issues with bank being dug out. New interim enforcement officer
  has started and Cllr Rose has asked for someone to go and have a look.
  Enforcement has also attended to look at issues with burning and there is
  evidence to support this. The lane is still closed until drainage improvements
  have been done.
- Speeding: Cllr Rose is conducting a survey on speeding and suggested the
  public and SPC highlight the on-going problem with speeding cyclists on the
  Greenway as an example, so it is easier to bring to officers' attention. There
  will be a specific consultation form for parish councils to provide a collective
  response on speeding issues.
- Local Government Re-organisation: Proposal for an east/west unitary split of the county. Potential impact on local amenities is not yet known.

## **Parish Councillors Report:**

## Cllr Price - Great Bridgeford

 Hedge on Newport Road, Great Bridgeford has overgrown onto the pavement leading to a complaint by MOP. Property owners are responsible for the maintenance. The hedge on the other side of the road also needs cutting back. Action: Cllr Price to provide addresses so Clerk can ask residents to cut back their sections of the hedge.

## Cllr Wilkes – Derrington

 One of the 'slow cyclists' signs on the Greenway has been found and reinstated. There are still issues with speeding cyclists and maintains that chicanes would be the most effective deterrent.

## Cllr Burgess - Great Bridgeford

• The Hollybush asked if SPC can new fund pads for the defibrillator in Seighford. Agreed in item 15/09/25/3.

## Cllr Hayward – Derrington

• Seighford footpath 5 needs clearing and is currently inaccessible. **Action:** Clerk to log onto system.

## **CIIr Brown - Derrington**

- MOP was recently metal detecting on the playing field.
- Chain and padlock still required for the playing field gate.
- No visible lifesaving equipment eg buoy around Millennium Green pond which is quite deep, so suggested looking into this.

## 15/09/25/8

## **Chairman's report:**

- Sign on Blackhole Lane has been replaced.
- Suggested placing a 'no horse riding sign' on the Greenway, but Cllr Rose said it is unclear as to whether horses are permitted or not and is trying to find out.
- Bus shelter in Derrington needs repair work.
- Has recently been helping at the Millennium Green car park.

## 15/09/25/9

## **Highways and Footpaths:**

a) To discuss repeated problems with the speeding cyclists on the Greenway and the removal and damage of official signage.

One sign has been found and reinstated. Explore SPC funding chicanes in the future.

b) To provide an update on the Health and Well Being Project for footpaths in the Parish of Seighford.

Cllr Price read out his report following a recent preliminary hearing comprising of five councillors. Five possible walks were discussed, however to get this project to fruition a lot of work will need to be done and it will take at least 12 months to get it ready, including agreement of the landowners, farmers and SCC to improve the network of rights of way. Cllr Price said he will contact Eccleshall PC to ask how they did theirs. They also produced an excellent booklet, which is accessible from their website. Cllr Rose added that the new Head of Rights of Way at SCC is actually carrying out a health and wellbeing project and will be contacting local parish councils to partner with on this.

c) To discuss issues on and around Dale Lane, Haughton

Enforcement team has been contacted and Cllr Rose will keep SPC updated.

## 15/09/25/10

## **Playing Field matters:**

- a) Provide an update on recent playground inspections and any maintenance work required on the three play fields.
- All councillors agreed they were satisfied with the new inspection company
  who conducted a comprehensive report highlighting several issues on all of
  the playfields which need attention. Councillors agreed to meet imminently to
  discuss the issues and prioritise what work is needed to ensure all equipment

remains compliant with safety standards. A professional contractor will be employed to carry out necessary work. Action: Clerk to request inspection company's guidance on next steps from the report and seek contractor recommendations from Staffordshire Play Fields Association.

- Access along Cherry Tree Crescent is still poor and moles have returned to Great Bridgeford play field.
- Grass needs cutting in Great Bridgeford play field.
- Clerk to ask Dan Ingham to cut hedges earlier in season before ground becomes too wet.
- Seighford playfield in poor condition with rubbish and mole hills everywhere.
- Remedial work on Seighford multi play equipment required by supplier and wood is splitting already.
- b) To discuss the outcome of the tree health and safety survey across the three playfields.

Comprehensive survey was conducted highlighting remedial work needed on trees. **Action: Clerk to get quotes from arboriculturists to complete work recommended in report.** Proposed: Cllr Price. Seconded: Cllr Brown. Approved.

c) To discuss solutions to improve fencing around the Seighford playfield. It was agreed a new fence is needed as current fence is in very poor condition. To discuss at extraordinary or November's meeting.
